## MOVE UPS AND CLASS TRANSFERS

From Regulations for AKC Scent Work: Chapter 3, Section 19. Class Transfers. A move up transfer may be requested if, according to the owner's records, the handler and dog are eligible, and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. A move-down transfer may be requested if the owner mistakenly entered the dog in a higher-level class for which it is not eligible. A lateral transfer (from section A to section B) must be requested if the owner mistakenly entered the dog in section A, and it is not eligible.

**Move Ups between trials WILL NOT be offered.**

## DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

**Conditions of the Dog:** Chapter 2, Section 3 of the Scent Work Regulations states dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no sign of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is always in control of the dog, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge

## ENTRY FEES

\*an entry is defined as a single run by a single dog, in a single class.

Entry fees include a \$4.50 per run AKC recording fee.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$35.00 collection fee to the amount of each returned check.

## WAIT LIST INFORMATION

RRNDOC is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 15 entries per day will be placed on the club's wait list. All entries, including listed entries, must be received by the closing date, April 10, 2026. If an entry withdraws and is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. No withdrawn entries will be eligible for a refund after closing date. All checks from participants on the waitlist that do not get an opportunity to participate in the trial, will be shredded.

## CRATING

**There will be no indoor crating.**

## VENDORS

**There will be no food or beverages for sale on trial grounds.**

## RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place.....	Blue

A New title ribbon will be awarded to those completing an Element Title.

A New title rosette will be awarded to those completing a Level Title.

A New title rosette will be awarded to those completing a Detective Level Title.

## HIGH IN TRIAL

High in Trial is being offered to teams who participate and qualify in all elements offered at one level. Novice A & B are combined for High in Trial.

The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. Teams winning High in Trial will earn a rosette. The High in Trial award is not recorded by the AKC.

## STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

**STAGING AREA** will be out of view of search area(s). All exhibitors will stage from their vehicles. There will be NO crating inside the building. The Staging Area Steward will be in this area for check-ins and posting of running order.

**THE HANDLER'S BRIEFING** will take place in view of the search area (if space allows) prior to the start of each class, after the hide(s) have been set and **AFTER** the Demo/Test Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. **NO DOGS** are to be present during the Handler's Briefing.

**WARM-UP AREA:** The club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers in the warmup area if they choose.

**NO DOGS ARE ALLOWED IN THE WARM-UP AREA UNLESS THEY ARE WARMING UP BEFORE THEY ARE CALLED FOR THEIR SEARCH. NO UNENTERED DOGS ARE ALLOWED IN THE BUILDING OR IN THE WARM-UP AREA AND MUST FOLLOW THE RULES APPLYING TO ENTERED DOGS**

## SEARCH AREA AND RING CONDITIONS

**SEARCH AREAS** may be of any shape, and of the size specified in the Regulations for each class.

**SEARCH AREA CONDITIONS.** Searches may be indoors, on matted, carpeted, or tiled surfaces, stairs may be utilized to get to search areas, or outdoors on uneven ground, grass, gravel, earth, concrete, or asphalt surfaces.

## ADDITIONAL SITE INFORMATION

**TRIAL SITE.** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training.** Chapter 5 Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area"

## NOTICE TO EXHIBITORS

### **SAFETY, BEHAVIOR and LIABILITY**

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Red River North Dog Obedience Club and its agents, employees, etc., will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Red River North Dog Obedience Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Red River North Dog Obedience Club or any official thereof.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. Wearable cameras such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must always be on leash, and retractable leashes may not be used when on trial grounds (except during judged searches).** Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

**REFUNDS**

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Dogs pulled after closing because of injury or other medical condition will be refunded all but \$6 per day contingent on trial secretary receiving verification of injury or illness signed by a veterinarian.**

**Bitches in season** will be refunded the full entry fee. Notification in writing, signed by your veterinarian, must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

**RINGSIDE**

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**EXHIBITOR CHECK-IN:** Exhibitors must **check in** with the parking lot steward **EACH day** they are entered. Check-in times for each level will be determined when the trial closes. All exhibitors will be notified by email with check-in time and dogs running order after trial closes.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

- Novice B Classes are open to all dogs.
- Advanced Classes are open to dogs who have achieved the Novice title for that particular element.
- Excellent Classes are open to dogs who have achieved the Advanced title for that particular element.
- Master Classes are open to dogs who have achieved the Excellent title for that particular element.
- Detective is open to dogs that have achieved a Master title in any element.
